

Morton Loggers' Jubilee

Rules for Lawnmower Races

1. Drivers must be 18 years or older.
2. No alcohol or Firearms allowed in pit area.
3. Drivers must wear helmets.
4. If the race committee feels anyone is not complying with the rules, you may be rejected from entry.
5. Track rules will be explained at drivers meeting. The drivers meeting is Mandatory to ALL DRIVERS.
6. Intentional "Ramming" is grounds for disqualification.
7. Anyone jumping the start flag will be sent to the back of the pack.

CHECK IN TIME & MOWER INSPECTION 3pm - 5pm

DRIVERS MEETING(Mandatory) 6:30pm

1. ONLY 00-99 Numbers. 5 inches high on both sides with WHITE BACKGROUND.
2. Blades must be removed.
3. Facsimile mowing deck must be in place.
4. Non altered lawnmower turf tires and rims only. No aluminum wheels. No knobbies or tractor type V-tread.
5. Stock lawnmower frame, chassis and suspension required. Reinforcement to the frame is allowed.
6. Steering arms and tie rods may be strengthened and steering wheel or handle bar may be used.
7. Gear ratios and pulleys may be changed. Must have lawnmower gearbox, transmission or transaxle.
8. Drive chains and belts that are exposed MUST be shielded.
9. Brakes are legal, but not mandatory.
10. Gas tank to remain under hood but may be moved. ONLY GRAVITY FEED carburetor. No fuel pumps, no Slide types.
11. Mowers must be equipped with GROUND KILL SWITCH that attaches to driver.
12. Engine must be stock appearing Briggs or Tecumseh 8HP, 8.5HP, 4 cycle(or smaller). No 5HP engines will be allowed.
13. WIDTH: overall width not to exceed 36" front to back.
14. HEIGHT: Must have front axel height of at least 5.5 inches.
